

## How Medi-Cal Supports Hospitals in Congressional District 41

edi-Cal is California's Medicaid program. It covers about half of the state's children, over two million seniors and people with disabilities, and close to one in five workers. In total, Medi-Cal covers nearly 15 million people, or about one in three Californians.

In 2023, Medi-Cal patients accounted for 37% of all visits to general acute care hospitals in California. Medi-Cal paid hospitals a total of \$39 billion — about 30% of the total net patient revenue for all hospitals in the state.\*


## How many people are enrolled in Medi-Cal in Congressional District (CD-) 41?

A total of 256,180 people (34% of all residents) in CD-41 <u>are enrolled in Medi-Cal.</u> That includes <u>98,000 children</u> and <u>roughly 32,000 seniors and people with disabilities.</u>

## **KEY FACTS FOR CD-41**

- ▶ Medi-Cal enrollees: 256,180 (34% of all residents)
- ▶ Medi-Cal hospital visits: 190,137 (33% of all visits)
- ➤ Hospital net patient revenue from Medi-Cal: \$460 million (19% of all net patient revenue)

Figure 1. Net Patient Revenue at Menifee Global Medical Center, by Payer, 2023.





## How much hospital revenue in CD-41 comes from Medi-Cal?

The most recent year of audited financial data shows:

- ➤ Some hospitals rely on Medi-Cal far more heavily than others. For example, 54% of net patient revenue at Menifee Global Medical Center comes from Medi-Cal (Figure 1, page 1).
- Figure 2. Percentage of Adjusted Patient Days at CD-41 Hospitals, by Payer, 2023




Notes: Adjusted patient days is an estimate of hospital use that incorporates both inpatient and outpatient volume. Total adjusted patient days by congressional district and individual facility is calculated using the sum of adjusted patient days by payer.

- ➤ About one in three (33%) of all visits to hospitals in CD-41 were for Medi-Cal patients (Figure 2).
- ➤ Medi-Cal accounted for more than \$460 million, or 19%, of net patient revenue for hospitals (Figure 3).
